He was a true club stalwart. Our wishes go to all his family.

Evan Gray continued his good work organising the club during a reasonably successful year both on and off the field;

On the field the club achieved 8 wins from 12 games played and there were 2 games cancelled due to bad weather. Team selection will undoubtedly become an important factor in regaining our success in these games (maybe a Blackcap or two can be encouraged to become members?)

A great new feature this year was a Secondary Schools T20 Tournament which was played for a new trophy kindly donated to the club by Sir Patrick Goodman. Eight schools entered the tournament with the Round Robin run over two days. This portion of the Tournament was well run thanks to assistance from Taita CC. The final between HIBS and HVHS was played at the Basin as a curtain raiser to a Wellington v Otago T20 game. Unfortunately the game was abandoned due to rain with the new 'Hunt Family Cup' being shared between the two teams. Not only was our Life Member Bill Hunt involved in this presentation but he was also honoured for his attendance at all 50 test Matches at the Basin by being asked to present the Blackcaps with their test Caps. Well done Bill.

Off the field the usual functions were held:

The cocktail function in conjunction with the Carillon Club saw Joe Bennett provide a smaller than usual crowd with very humorous stories.

Breakfasts were held before both the Pakistan and Australian Tests and while earning valuable revenue were not as successful as previous years. While one can speculate as to reasons for the lack of success I can assure members that future focus will be placed on having a single high quality function to try and ensure the Test Breakfast remains a feature on Wellington's cricket social calendar.

The last major function was the Golf Day held at Manor Park which saw a field of 24 taking part. Despite an improved team selection this year the Presidents Team finished well down the list once again, but enjoyed another great day of golf. Thanks must go to Leisure Days, Kevin Kelly, Kirstin Phipps, Alan Hunter and Manor Park Golf Club for their assistance in making this a great day and a successful fundraiser.

TENDULKAR TO PLAY FOR ENGLAND

Sachin Tendulkar, the greatest batsman in the world is to play test cricket for England. Negotiations went on long into the night as the England and Wales Cricket Board sought to persuade the star that his future lay with England.

England captain Andrew Strauss revealed, "We have discovered a clause which allows anyone from the former British Empire to play cricket for England. Previously we thought this only worked with South Africans, so we picked loads of them," said the South African Strauss. "Now we know that Indians, Australians, New Zealanders and West Indians can also play for England. At last we shall be the best team in the world."

Tendulkar is idolised in India. He has the pulling power of a Hollywood (Bollywood) star, so his defection from Indian cricket would be a major blow. Only the other day he became the first batsman to score a double hundred in a one day international. The double hundred, 204, came off an impossible 33 balls. Scorers were questioned about the apparent error, but after a 30 minute recount the rather dubious figures were held to be correct – and described by the Indians as 'a miracle'. India will surely oppose any attempt to steal him away.

Not all of his potential new team mates are pleased. Kevin Pietersen is particularly angry. "You just can't decide that you are English because it is convenient for you. National identity needs to be nurtured. You have to be a real Englishman to understand the power of the three lions on your chest," said the South African born and raised batsman.

Treasurer Murray Coppersmith presented the annual accounts commenting on the ongoing effort required to raise the necessary funds to keep the club going in its present form with a paid Club manager. He did note that so far this year we were on track to obtain the necessary funds for the current 2009/10 year through Evan organising profitable club functions such as Test match breakfasts, the annual Golf Tournament, successful application to NZCT and Infinity Charitable Trusts and running a cocktail party with the Carillion Club.

John Revell asked about the ongoing availability of Trust money. Murray Coppersmith replied that nothing was certain but at the moment we have arranged approximately 50% of this year salary for Evan Gray.

Duncan Priest asked it we would be having a Test breakfast for both

Pakistan and Australia games. Evan Gray replied that in all probability we would.

Roger Kinsella asked about on-going costs with running the website. Chris

Taylor replied that Paul Steele was in charge of that project and that costs would be minimal as the site would be updated by Evan Gray.

Murray Coppersmith moved the adoption of the Annual Report and Statement of Accounts. This was seconded by Mathew Roche. The motion was carried.

Murray Coppersmith noted that new accounting rules stipulate that the same auditor can only hold a position for a certain number of years and as Dennis has been in the position for many years now, we may have to address this situation soon.

SUBSCRIPTIONS: These are to remain as last year: \$50 for playing members and \$25 for non-playing (associate) members. Moved: Murray Coppersmith. Seconded: Richard Allan. Motion carried.

AMMENDMENT TO CLUB RULES: Alasdair McBeth (Club member the Clubs legal adviser) tabled a paper with proposals to amend the Clubs rules to bring the Club into line with the requirements for registration under the Charities Act 2005.

- 1. In the event of the winding up of the Club: A rule is to be included in the Clubs rules so that surplus assets of the Club will be distributed solely for charitable purposes upon winding up.
- 2. The application of Club monies: A rule is to be included in the Clubs rules that prohibits private pecuniary profit as follows:
- 1.1 Any income, benefit, or advantage must be used to advance the objects and purposes of the Club.

- 1.2 No Member, or anyone associated with a member, is allowed to take part in, or influence any decision made by the Club in respect of payments to, or on behalf of, the Member or associated person of any income, benefit or advantage.
- 1.3 Any payment made to a member, or person associated with a Member, must be for goods or services that advance the objects and purposes of the Club and must be reasonable and relative to payments that would be made between unrelated parties.

These changes were suggested by the Charities Commission to strengthen the 'Club's Rules.

Duncan Priest asked how it would be decided which Charity the Club would choose. Alisdair McBeth replied that it would be decide at a special meeting of the Club.

Richard Dean asked for clarification as to whether the A.D.Grey Trust was a separate entity from Club with regard to any winding up of the Club. Alisdair McBeth replied that the trust was completely separate.

The changes to the Club's rules as tabled by Alasdair McBeth were moved by Murray Coppersmith and seconded by Alisdair McBeth. The motion was carried.

GENERAL BUSINESS: President Chris Taylor thanked Evan Gray for his work as Club manager; The community trusts who supported our applications for funding; Richard Allan for his secretarial work; Murray Coppersmith for his extensive accounting work – especially with obtaining our charitable status; Alasdair McBeth for his legal advice and the members of the Club's committee, for their work.

OBITUARY DOM POST SATURDAY 24TH OCTOBER 2009 A GOOD SPORT AND LIVELY RACONTEUR AT THE BASIN

Larry Macer was a stalwart of Oriental Rongotai Football Club for over 60 years – a player, supporter, referee, organiser, fundraiser and life member – the sort of character who helps keep so many clubs going.

Born in Timaru he was the youngest of eleven children in his family and he was fifteen when his father died in a bridge-building accident in South Canterbury.

The teenaged Larry moved to Wellington to live with his married sister but he did not stay long.

A sense of adventure prompted him to sign up as a seaman, and he worked as a stoker on coasters and ships plying the Tasman.

After the outbreak of WW11, he joined the British Merchant Marine and his 21st birthday was celebrated on one of the hazardous Arctic convoys to the northern Russian port of Murmansk.

He was on one of the fleet of merchant ships carrying provisions in support of the Allied D-Day landings on the coast of France in 1944.

After marrying and living in Wales, he came to Wellington soon after the end of the war and bought the family home in Bowes Crescent Strathmore Park where he lived for the rest of his life.

The marriage ended in divorce after about 12 years. Friends described him as a bit of a lad, whose primary interest was always sport. Nevertheless, he was a caring father and always enjoyed encouraging young people to enjoy their sport.

Mr. Macer joined the Oriental Rongotai club when it was based in Hataitai and played in the Junior 1st Division which won its competition.

He was a front - row forward and had the broken nose and damaged ears to show he had served his time in rucks and scrums.

His first job back in Wellington after the war was at the Tramways workshops at Kilbirnie, and he later worked as a store man at the Bonds Hosiery factory in Newtown.



It was a position that helped him ensure his teams were always immaculately turned out with good jerseys and socks and there was also packets of pantyhose – factory seconds of course – with which clubmates were supplied to keep their wives and girlfriends happy.

Mr. Macer was also a keen cricketer. He helped form the works cricket team and played as a wicketkeeper in teams that played in the Mercantile League and Wellington Cricket Association competitions.

He kept playing as long as he could and was a long time member of the Wanderers Club and a life member of the Collegians Club.

Friends remember him as a great story teller.

Always active, he only slowed down in later years when he needed a walker to help him get around.

As he became more housebound, he would keep himself occupied at home as a self appointed guardian of the Wellington Harbour entrance.

The Bowes Cres home, high above the southern tip of the Miramar Peninsular, had spectacular views over the main shipping channel, and with a shipping log and a set of binoculars, he would keep a lookout and tick off the big ships coming and going from the harbour.

The Hunt Family Trophy

In a break from the past, and with a view to the future the club organised a T20 tournament for the College First XIs.

The teams played for the "Hunt Family Trophy". This magnificent antique sterling silver trophy was donated by Wanderers member Sir Patrick Goodman. The Hunt family played a major part in the formation of the Wanderers Club over



60 years ago when Wyvern (Bill) Hunt and several others conceived the idea of a Wanderers Cricket Club to play matches against College XIs. Sir Patrick Goodman captained the St. Pats Silverstream First XI against the Wanderers in that inaugural season.

In his last year at St. Pats Silverstream Sir Patrick Goodman won the accountancy prize. In those days academic achievements were recorded in the Evening Post. The accountancy firm of Ernest (Father of Bill) Hunt and Turner contacted the college to offer the young Pat Goodman a job on leaving college. Pat duly joined the accountancy firm and was closely looked after by Bill Hunt. Bill would often say to Pat, "Goodman you are working with me today." That would invariably mean they were off to the tennis at Central Park, rugby at Athletic Park or down to the Basin for the cricket.

Pat Goodman had a sense of duty and would often come back after work to put in extra time in lieu of time out at various sporting events.

Pat Goodman worked at Ernest Hunt and Turner as well as attending Victoria University. He found the work required to hold down a full time job and study in the evenings was too much, and after a memorable meeting with the Accountancy Professor at Victoria University who asked his young student whether he knew where Queens Wharf was, and if he didn't like the work load to take himself down there and jump off. Pat Goodman eventually gave his varsity studies away and worked full time with Ernest Hunt and Turner. Interestingly at the desk beside him was a young Tom Williams later to become Cardinal Tom Williams.

Pat Goodman was to leave Ernest Hunt and Turner and return to Motueka to work in the family bakery along with his father Ledger and his younger brother Peter. The rest they say is history.

The friendship formed all those years ago between a young accountancy student and his employer has endured to this day and Sir Patrick Goodman was delighted to present the "Hunt Family Trophy" to Wanderers to be played for between the Colleges.

AUDIT REPORT

To the Members of the Wellington Wanderers Cricket Club (Incorporated)

I have audited the financial report on pages 1 and 2. The financial report provides information about the past financial performance of the Wellington Wanderers Cricket Club (Incorporated) for the year ended 30 June 2010 and its financial position as at that date.

Club Committee

The Club Committee is responsible for the preparation of a financial report which fairly reflects the financial position of the club as at 30 June 2010 and of the results and operations for the year ended 30 June 2010.

Auditor Responsibilities

It is my responsibility to express an independent opinion on the financial report presented by the Club Committee and to report my opinion to you.

Basis of Opinion

An audit includes examining, on a test basis, evidence relevant to the amounts and disclosures in the financial report, it also includes assessing:

- the significant estimates and judgements made by the Club Committee in the preparation of the financial report; and
- whether the accounting policies are appropriate to the Wellington Wanderers Cricket Club (Incorporated) circumstances, consistently applied and adequately disclosed.

I conducted my audit in accordance with generally accepted auditing standards in New Zealand, except that my work was limited as explained below. I planned and performed the audit so as to obtain all the information and explanations which I considered necessary in order to provide sufficient evidence to give reasonable assurance that the financial report is free from material misstatements, whether caused by error or fraud. In forming my opinion I also evaluated the overall adequacy of the presentation of the information in the financial report.

Qualified Opinion

Control over revenue prior to being recorded is limited, and there are no practical audit procedures to determine the effect of this limited control.

In this respect I have not obtained all the information and explanations that I have required.

In my opinion, except for adjustments that might have been found to be necessary had I been able to obtain sufficient evidence concerning revenues, the financial report fairly reflects the financial position of the Wellington Wanderers Cricket Club (Incorporated) as at 30 June 2010.

My audit was completed on 3 September 2010 and my qualified opinion is expressed as at that date.

2. Surplus on Club Functions

Fixed assets are recorded at cost less accumulated depreciation. The straight line depreciation rate applied to both playing jerseys and computer equipment is 33.3% per annum.

ALAN ISAAC – VICE PRESIDENT INTERNATIONAL CRICKET COUNCIL

The saying goes that you can take the man out of Johnsonville but you can't take Johnsonville out of the man. This is certainly true of Alan Isaac who was driving to the Johnsonville Cricket Club to attend a planning meeting for the upcoming 125th anniversary celebrations when he received a phone call from the CEO of the International Cricket Council Haroon Lorgat, informing him that his nomination for Vice Presidency of the ICC had been successful.

There has been plenty written in the lead up to the appointment but there is no denying the singular honour that this appointment brings to Alan, his family, New Zealand Cricket, Wellington Cricket, Wellington Wanderers Cricket Club and the Johnsonville Cricket Club.

Alan attended Johnsonville West School and from there he went to Onslow College from 1965-1969 where he was the last Head Boy. There is no doubting Alan's scholastic abilities finely honed at Onslow College, Victoria University and later at KPMG where he was employed for 35 years finally retiring when holding the position of "National Chairman" KPMG.

Studies aside, he was an outstanding all round sportsman excelling at many sports. He was in the First XV with Jeremy Coney, Richard and Steve McKenzie, Rory Lee and Rob Kuiti, in the First XI with Jerry Coney and the McKenzie brothers, and as a second winter sport played in the Indoor Basketball team.

He was selected in the Centurion Colts with Grant Batty and in the Wellington Secondary Schools Rugby side for two seasons, and before that in the Wellington Primary School Cricket and Rugby Reps with Grant Nisbet.

As a youngster he played in the Wellington rep softball side with Bryce Quarterman, Phil Peters and Lauren Algar all of whom went on to play International softball.

On leaving school and attending Victoria University he played senior rugby for University and WCOB.

Cricket was his first love and Alan was immediately in the Johnsonville Senior Side and went onto be part of the most successful era in Johnsonville CC history. In one period in the late 70's and early to mid 80's Johnsonville won the Senior Championship (Cook Shield) four times in eight seasons. Alan was captain in two of those and the late Stew Cater the other two.

He was selected for two years in the Wellington Brabin Shield Side and had four years in the Rothmans Wellington U23 side, two as captain before going on to captain the Wellington B representative team for a number of seasons.

While there are a number of stories he could tell when remembering his cricket career, his favourite stories centre around the Johnsonville Cricket Club.

One memorable occasion Johnsonville were playing University and were 8-16 chasing University's first innings total, and in grave danger of falling short of the follow on. Nigel Blair and Isaac rescued the situation somewhat and took the Village through to 9-50, when the late Robbie Turner batting eleven joined Isaac. They put on 105 for the 10th wicket, Isaac making 100 while Robbie Turner made 1 in 68 balls. The follow on was averted, Richard Pither the Varsity captain set Johnsonville a chase in the fourth innings and the Villagers duly obliged by winning outright, off the last ball!

That story is fairly typical of Johnsonville Cricket Club in those years. They were a fiercely competitive side who fought tooth and nail for any advantage they could get. The same side were most generous hosts in the clubrooms come 6pm and it was a very difficult place to leave late on a Saturday night.

Alan Isaac didn't only contribute to the playing side of cricket. He was a Wellington Shell Shield Selector for five years, he served for over twenty years on the Johnsonville CC committee and he took over from Malcolm McCaw as Treasurer of the Wellington Cricket Association. He was on the WCA management committee for 12 years and went from there to the New Zealand Cricket Council where he was a board member for many years before being elected Chairman, recently moving from that position to Vice President International Cricket Council. He will hold that for two years before becoming President for two years form 2012.

He will work well with current CEO Haroon Logart. Logart was a senior partner of Ernst and Young (South Africa) from 2002 until 2007, so in many ways they are kindred spirits. His work within KPMG means he is eminently qualified to deal with the many personalities and differing factions that make up the ICC.

He is passionate about implementing a world test match championship, believing that test cricket is the ultimate test of a cricketer.

He hopes through his position as Vice President ICC to help improve the image and credibility of the ICC and garner more support worldwide for their decisions while accepting that there may not always be one correct answer.

He will be supported in the role by Mary, his wife of thirty six years and his three sons, Trent, Ryan and Brad.

Alan Isaac will accede to the position of president of the ICC for two years beginning in 2012. He sees this role as part "Ceremonial" and part Governance."

He will do an outstanding job.

Wanderers Cricket Club in conjunction with College Sport Wellington and Cricket Wellington organised the First College T20 tournament which was held over two days at Fraser Park in mid December.

The teams were playing for "The Hunt Family Trophy," a magnificent antique sterling silver trophy donated to the Wanderers by Sir Patrick Goodman for competition between the colleges.

There was a lot of work involved in organising such an event. Sport Wellington's John Hornal and Tracey Devereux gave valuable guidance. All the colleges in the Wellington region were contacted and the first eight to reply were selected. The eight colleges who entered were St. Pats Town, Wellington College, Tawa College, Paraparaumu College, HVHS, HIBS, Rongotai College and Aotea College. Unfortunately Aotea pulled out the day before the tournament started and couldn't be replaced in time.



GOVERNOR GENERAL'S MATCH



WYVERN'S 50TH TEST

Close -run but he's made every Basin test

(Article from Sam Worthington's Dominion Post article 3rd December 2009)

Wyvern Hunt brings up his half-century at the Basin Reserve today.

The 91-year-old Wellingtonian has attended every test match at the famous ground and today's, against Pakistan, is number 50. Mr. Hunt handed the New Zealand players their test caps last night, a thrill for a man with a lifelong love affair with the gentleman's game.

"It is an honour, no doubt about it," Mr. Hunt said.

He didn't have much advice for the Black Caps, though a larger victory than the 32 run first -test thriller would be nice. "A more comfortable victory would be easier on the health of an elderly person," he said.

Mr. Hunt's and the Basin's first test was against England in 1930. It was a draw, memorable for a record opening partnership of 276 between New Zealand's Stewie Dempster and Jack Mills. "I was 11," Mr. Hunt said. "I only saw one day. When I say 'I've seen every test.....I certainly haven't seen every ball bowled."

Mr. Hunt has seen many faces of the Basin, and most notable were the change from a rectangular ground to an oval in 1980 and the construction of the RA Vance Stand in 1981.

His fondest memory was Richard Hadlee's match-winning haul of 10-100 in New Zealand's first test victory over England in 1978, but he admitted the Basin could have its off days. "I don't go up in the RA Vance Stand in a southerly."

Mr. Hunt's proud record was nearly interrupted in 2005 when a grandson's wedding in Canberra clashed with a test, but the Basin remained a magnet. "Two days later I came home. I don't know whether that stands to my credit at all. My late wife wasn't 100 per cent well. So it wasn't a bad idea anyway but I must admit it was a bit of a bonus for me to get back and see some of the test match."

Now living in a Kilbirnie retirement home, Mr. Hunt said he always enjoyed a cold lunchtime beer in the Long room members' lounge and was looking forward to another today.

The Basin is the 11th venue in the world to reach 50 tests and, despite a poor build-up; the forecast is for five fine days. New Zealand leads 1-0 and can seal the three-match series with a victory in Wellington. Play starts, weather permitting, at midday.

"I don't like these 12 o'clock starts and 7.30pm finishes," Mr. Hunt said. "That doesn't suit me at all at my stage in life and in fact I don't think it ever would."



SCOTS COLLEGE WELLINGTON

Virtutem Paret Doctrina Let Education Make The All Round Man

The vision and energy of the Very Rev. Dr. James Gibb, minister of St. John's Church in Wellington, and the practical capabilities of Hon. J.G.W. Aitken, M.L.C. that led to the foundation of Scots College in 1915.

The first home for Scots College was the former home of T.C. Williams at 53 Hobson Street, Thorndon. From the day the school opened in Thorndon it was recognised that this could only be a temporary home. The Board recognised that there were no playing fields; and to allow the proper development of Scots, a purpose built school and boarding facilities were seen as essential.

The Crawford property in Miramar was available and the Board decided on 6th March 1917 by a majority of ten to three to buy the land at Miramar rather than another area offered, the Lancaster Estate at Karori. The foundation stone was laid in 1918 and the new school finally opened a little late on 28th February 1919. The accommodation and dining facilities for boarders were complete but the school building itself was far from finished. In those early days lessons were held in marquees on the school grounds, two classes at the Presbyterian Church in Kilbirnie, one each at the Presbyterian Church in Seatoun, the Anglican Church in Seatoun, and one class in the Pump House in Miramar. A strange start for a school that was to become a focal point for the Miramar community.

In the curriculum of Scots, considerable attention has always been paid to sport with the view being held that "more things than school studies count in the salvation of a boy's soul"

The school has produced a number of notable old boys, Lord Grey of Naunton, last Governor of Northern Ireland, John Clarke, satirist and comedian, Ashley Fogel, fashion Designer, Rocky Wood author and journalist, and on the sporting side, former All White Stu Riddle, former Blackcap Richard Reid, former All Blacks James McCormick and Chris Tregaskis and current All Black Victor Vito to name but a few.

Recent developments have seen the school take giant steps on the sports fields. This year the College Ist XV defeated Wellington College Ist XV for the first time; the Cricket XI is in the first division of College Cricket and has only recently returned from a trip to South Africa. The junior cricket XI finished fifth at the Junior Gillette Cup and the school continues to make giant steps in Basketball, Football and Tennis.

Fulltime appointments in both cricket and rugby should see this progress continue. Brent Miskimmin is coaching the hockey Ist XI and Matt Calcott the Ist XI football team, while Miramar golf club has programmes for Scots and the Evan's Bay yacht Club runs the Scots College yachting academy.


As we go to press two big projects are underway at Scots. A \$17 million Arts and Cultural Centre is being built along Monorgan Road and a \$3 million Covered Sports Centre is being built on the main sports field with completion due for May 2011. While the focus for this Athfield designed centre will be a four lane indoor cricket centre, it is a multipurpose venue and will include offices, changing rooms and video facilities. It is also ideally suited for hockey, football and general fitness classes. The design of the building means that it will have an outdoor feel while being completely covered. Natural light will ensure this indoor centre becomes the premier indoor facility in the Wellington region.

In addition to being used by Scots College it will be available for community use.

The existing Ist XI block will be moved slightly towards the Broadway and grass practice pitches will be established alongside the indoor centre. This facility together with the Arts and Cultural centre will make Scots the envy of every school in the Wellington region.

Scots College under Principal Graeme Yule, his staff and Board of Governors has "Dared to Dream' – They are certainly living up to their motto of "Let Education Build The All Round Man."

The future is exciting for Scots College in 2010 and beyond.

DIARY OF A TEST MATCH

UMPIRE TONY HILL'S DIARY OF THE 3RD TEST ENGLAND V PAKISTAN PLAYED AT THE OVAL (AUGUST 19 – 23 - 2010)

Day 1

Third test underway and it has been a pleasant wait in between games. Fairly quiet in London, just going for walks to keep the ancient body moving and to help pass the time through the long cool days.

We went to the Oval yesterday to watch England practice and to check out the usual bits and pieces that are part of the preparation, rollers, cutting, sightscreens, umpires room etc. As you can see from the photo, the covers were on; there had been a few drops of rain.

As always, an interesting day at the office. I had a decision overturned in the first hour (Strauss caught behind). If you have ever wondered, yes, it makes the rest of the day even tighter as you work hard to keep everything else on track.

With the nature of this game though, that doesn't always happen! Having given a couple of the Englishmen out LBW to finish off their innings I ended the day with some decent shouts against the Pakistanis just to make sure that I was paying attention. Long day, arriving at the ground at 9.15am and played through until 6.30pm – now it is a very quiet evening in my room – time to catch up with the mail and get some decent sleep I hope.

Eleven wickets during the day does mean the game has progressed a fair bit. We lost a wicket in the last over of the day and the players were surprised to find that we weren't leaving the field. Isn't it amazing how many of the players don't really understand the playing conditions!!?

Mind you I sympathise with this one as it does provide a slight inconsistency with leaving the field at other intervals – however they're the rules!!

Day 2

In my room at 7.40pm eating a banana. Liverpool are live in a few minutes in a European Cup game – quiet end to my day. Eleven wickets fell yesterday, ten more today so the game has pushed forward quite a bit. England now batting again, one down and 70 behind – plenty to play for tomorrow.

Today most of the noise came from Shrek's (Steve Davis) end. I am sure not complaining though and as we have swapped ends before the end of day 2, there is plenty of time for my turn tomorrow and later! Lots of chats needed today and our team seemed to have that mainly under control. Communication is important for us at all times.

Interesting walk through part of the crowd as we enter and leave the field. Some lucky bugger always sitting there with a cold pint - I have to steer Shrek past those types. Mind you he does his best to get into trouble at any time of the day.

Good fun though and there is a constant banter through the room all day – shudder to think what it must be like in the 3rd umps room with John Holder having naps all day and Billy and Ranjan playing jokes on everyone.

We changed the ball today – England bowling. Last time England v Pakistan at the Oval and a ball changing incident occurred, it was an entirely different situation as most of you know. Our change caused a quite murmuring in the crowd!

Ok, football's on so ready to watch.

Day 3

What a strange day – what seemed like a long slow slog for a decent lead has been shattered and the game has pushed a long way forward. On top of all the runs and wickets over the past two days there have been some bizarre happenings.

First up we had a request for sawdust in the middle. I signalled our request to the ground staff and they sent out a young Aussie to see what we wanted. When he worked out what we wanted he returned with a bucket and helpfully placed some on the landing spot. I then asked him to leave the rest behind the bowler near the signage area. He went down there put the bucket down on the spot and walked off the field.

That was just the first of the crack ups as Shrek would say,

We had Cook struggling for runs initially, and then got into full stride. As he neared his 100 you could feel the tension. He played one back to Asif – he fielded the ball cleanly then elected to throw it to the keeper. He threw it straight over his head for four overthrows gifting Cook his 100. The crowd erupted and teased Asif unmercifully for the rest of the day.

Later after tea, all hell broke loose and wickets fell all over the place. The light went so we used the lights but eventually had to take them off. The crowd

weren't happy and abused us as we left the field. Pity they didn't consider how much play we had actually had during the day. We had two streakers while waiting for the light to improve both male!

For a day that started with not much to recommend it, the possibility of a long day and plenty of runs followed by a declaration later, things have now all changed. England now only 140 in front with one wicket left. Plenty still to come tomorrow.

Day 4 (all over)

That was some day out there. We never finished the four balls left from yesterday and wickets were already underway. Stuart Broad asked whether they should review any 'out' as they still had one up their sleeve. He hoped they may have a no ball and escape – I told him to watch the first ball from Amir as he was well behind the line and a review would look silly if the 'out' was obvious. He must have listened because when he holed out a few balls later he didn't review.

However that was just the beginning. From there we had Pakistan chasing 148 for a win – a wicket early meant everyone was on their toes. Two overs of pace from my end and then Swann for the remainder of the match. Yesterday it was Ajmal for most of the day... now here we go again. Not too much turn or bounce, only occasionally, but both guys making sure you were watching.

Sure enough I am called on for a few shouts and an LBW goes up for review. The crowd now were warming to the day and the noise was lifting. The review showed what I had thought, Butt is still in.

The Pakistan lads batted well to lunch only three down and 30 odd to get – should be a breeze – yeh right! The hour after lunch saw only 17 runs and 3 wickets fell. The crowd was baying for more and gave their side a huge lift every over. They responded well and made it hard for runs at all stages – great cricket, neat atmosphere (ground sold out) and plenty happening.

Another review, me again and my decision stood, one for Steve too and his decision stood. Each run was ground out until a little flurry at the end. Pakistan wins, series 2-1.

Good TESTing time for umpires – good teamwork helped too – another game next week this time at Lords.
